Meeting called to order at 7:00 p.m.
The Pledge of Allegiance was recited.
Present: Spaulding, Asher, Seaford, Fuller and Pedersen.
The Treasurer's report was received.
Minutes of the August 7, 2019 Regular Meeting were approved as distributed.
Motion by Fuller supported by Asher to approve the bills for August 2019.

Winter Tax Levy for 2019 Millage.

Motion by Fuller supported by Asher to approve the 2019 winter tax roll as follows:

Solid Waste/Trash Collection.

The current annual rate for trash assessment is \$136.65. There will be no increase for the 2019 winter tax bill.

Dangerous Buildings Advised for Removal.

Motion by Asher supported by Fuller to submit the following three (3) parcels to the Houghton Lake Building Agency and the Dangerous Building Officer for the issuance and service of a notice of a hearing on whether these buildings are deemed dangerous. Sand for Sullivan Beach.

An estimate in the amount of \$2,400.00 for 150 yards of beach sand for Sullivan Beach from Sergeants Septic and Excavating, LLC was reviewed.

Motion by Pedersen supported by Spaulding to authorize the purchase of 150 yards of beach sand to be delivered to Sullivan Beach from Sergeants Septic and Excavating LLC at a cost not to exceed \$2,400.00.

Tree Removal Estimate from T & P Tree Service/Mobile Home Park.

Two (2) estimates for tree removal at the Mobile Home Park from T & P Tree Service was reviewed.

Motion by Asher supported by Fuller to approve the estimates from T & P Tree Service for tree removal at the Mobile Home Park. One double maple tree at \$795.00 and one large oak tree at \$925.00.
